

Mural Depicts History and **Natural Resources of Our County**

A mural by South Coast artist Lauren Sinnott was painted this year on the front wall of the Foundation's Community Room, depicting the vibrant history, geography, and resources of Mendocino County. As Lauren puts it, "The Community Foundation works hard to give its full attention to every one of our regions and so did I."

The mural is oriented with the ocean at the bottom and the county laid out north-to-south, so viewers see the county as if they are slightly above the ocean, looking eastward. Lauren references the major geographical elements, including mountain ranges, rivers, lakes, and valleys. In each of the seven regions

> there is also an element of architecture, a representative tree, and an iconic animal including the horse Seabiscuit, a blue whale, salmon, a harbor seal, an elk, a bear, a hawk, deer, and a mountain lion.

In addition to the mural, seven story boards along the walls of the Community Room will include depictions of the Foundation's current work in the various regions of the county. The hope is that every person visiting the room will walk away with an appreciation of the individuality of each area or community, and a recognition of the interconnectedness of the regions.

Bishoffs Leave Legacy Funds at the **Community Foundation**

Chatter and Jack Bishoff, cherished The Bishoffs began their association with

members of the Mendocino and Little River communities during their lifetimes, are continuing their support of local non-profit organizations through legacy funds at the Community Foundation. The funds will provide on-going grants to organizations named by the Bishoffs. the Community Foundation in 2004 when they included the Community Foundation as a beneficiary in their trusts and established a charitable remainder trust with the Foundation. The latter provided income to the Bishoffs during their lifetimes and left a "remainder" to the Community Foundation. At the time they said they wanted to do something special, to give back to the community they dearly love, and also to leave a perpetual remembrance of their place in this close-knit community.

Making Connections in a **New Community**

When Steve and Jan Pearson moved to the Anderson Valley full-time they approached the transition with enthusiasm. Having recently retired as Chairman of Asian Operations for a large engineering firm, Steve was ready to learn more about how he and Jan could contribute to their new community. "We were working on a plan for giving, both short-term and long-term through our estate plan," Steve explains. "I knew we wanted to concentrate on Mendocino County and so we contacted the Community Foundation."

The Pearsons eventually transferred money from an institutional charitable fund to a donor-advised fund at the Community Foundation. "We learned so much from working with the staff," Steve says. "They helped us understand local needs and how we could get involved. My interests are in the environment, while Jan wants to help children. Working through the

Community Foundation, we were able to find programs that addressed both."

Programs supported by the Pearson Family Fund this past year include: the Redwood Forest Foundation's Biochar project; Anderson Valley Land Trust's interpretive walks conducted by visiting botanists and geologists; sending Anderson Valley Elementary School students to Mendocino Woodland's science camp; and providing Anderson Valley High School with new science lab equipment, including four advanced microscopes. "The science teacher. Kim Jenderseck, told me that it was one of her wildest dreams to have microscopes like these in her classroom," Steve says. "It was particularly satisfying to me. As someone with a science background, I want to see strong science classes at my local high school."

"We tend to get into things guickly and get involved. The Community Foundation has helped us do that. People who are new to the community need to have ideas about how to give back most effectively. The Community Foundation gives focus to our giving."

The Right Path after Graduation

George Madrigal grew up in Willits seeing first-hand the importance of hard work. He recalls, "My dad, Agustin, and his entire family were migrant farm workers, and then Dad went to work for the railroad. Eventually he was employed by Remco. On the weekends he did yard work and took my brother and me along to help. When I graduated from high school, there was pressure to stay in town and work. However, my mother, Eugenia, who grew up in Mexico and had worked hard as a housekeeper, insisted I go to college like my older brother, and that is the direction I chose."

It was this important decision that led George to a very successful career that included being in charge of international equity portfolios for major investment houses (Wells Fargo, Barclays, BlackRock), and being the founder and CEO of Penserra, an institutional financial services firm focused on global equity trading and asset management. Throughout his career journey, George has retained his love of family and community, and his belief in the importance of education.

Now, through the Penserra Founder's Scholarship Fund at the Community Foundation, George is bringing that focus back to Willits. "I want to help students who haven't had it so easy, especially the kids with immigrant backgrounds who have stayed focused throughout high school. There are so many pressures on these kids to go right to work after graduation. I want to give them an incentive to continue their education. It was certainly the right move for me."







Judy Pruden Honored with Fund for **Historical Preservation**

Judy Pruden left a legacy in Ukiah through her many crusades to plant trees, create community events, and preserve the history of the town and the region. As John McCowen wrote in a memorial tribute, "Ukiah's history is written in many books, but Judy knew it by heart."

It is this legacy that Mike Morgan, Judy's husband, wanted to honor and see continued when he created the Judy Pruden Historical Preservation Fund. "We need to have people in the community who are working to do some of the things Judy believed in and went to bat for. The hole left by Judy is a tough one to fill. This fund will encourage others to do things that may help fill that hole."







Jane Anderson Developmental Disabilities Fund **Cycle Without Limits**

It was a happy week at the Alex Rorabaugh Recreation Center (ARRC) gym during a Cycle Without Limits bike camp, partially funded with a grant from the Jane Anderson Developmental Disabilities Fund. Campers of all ages rode bikes that were adapted to allow them to have a feeling of balance, security, and freedom. Some rode with a volunteer on a tandem bike, others on bikes that use air cylinders to keep the bikes upright, and some had a volunteer running alongside the bike and holding a fixed tether.

Cycle Without Limits is a program provided by United Cerebral Palsy of the North Bay (UCPNB) that teaches people with disabilities how to ride a conventional two-wheeled bicycle. The organizers of the camp were Tina Tyler O'Shea and Denise Gorny. Denise is an advocate for people with disabilities and a member of the ARRC board. She volunteered to handle the administrative details of the camp saying, "Once people learn to ride, it evens the playing field and gives them so many more opportunities for independence. It really is a life changer."

At the end of the week when the bike camp concluded, many of the campers had made tremendous progress. One 45-year-old woman exclaimed that this was her "first time riding a bike." Several of the campers were able to ride their bikes outdoors on the playground as if they had been riding for a long time. Tina said, "The campers have progressed at an incredible rate. Best of all, they have been able to overcome their fears."

In Appreciation of Susanne Norgard CEO 1999 - 2016

In 1992 an organizing committee with bold goals and a county-wide vision began formulating the Community Foundation of Mendocino County. They hired Susanne Norgard as the first executive director in 1999. She has been at the helm ever since, overseeing the growth of the Community Foundation's endowment from just a few thousand dollars to over twenty-seven million dollars today. Over her tenure, more than eleven million dollars have been granted to community organizations.

Susanne has worked professionally in the county since 1988. Since taking the job at the Community Foundation, she has lived and kept an office on the coast while commuting to the Foundation's Ukiah office. Early on she developed a countywide network of volunteer advisors to ensure the Community Foundation serves all communities. She has served as a strategic partner to the board and staff, and has worked closely with donors from all walks of life to ensure their philanthropic goals are realized through their work with the Foundation. Susanne retires from the Community Foundation with the knowledge that she is leaving a strong community asset and resource. "It has been amazing to have had the opportunity to lead an organization that has been so closely aligned with my personal goals and beliefs," she says. "I will miss the Community Foundation, but look forward to seeing it grow over the coming years and increase its contributions to all aspects of our lives

in Mendocino County."
